**Since the number of delegates is limited, the Organizers do not guarantee acceptance of applications for participation in the Conference if sent after October 10, 2014.**

**Since the number of speeches at the Conference is limited, the Organizer has the right to reject the application for participation with a report if sent after September 30, 2014.**

**PAYMENT PROCEDURE:** an invoice to pay for services shall be sent to the Participant via fax and/or e-mail based on the filled in AGREEMENT. The Participant shall pay by wire transfer 100% of the prepayment in Euro.

The payment shall be made within 10 (ten) banking days from the date of the invoice.

**All bank charges and commissions are debited from the Payer's account.**

Delegates who make a report shall pay their registration fees before October 1, 2014.

Delegates who failed to pay the invoice prior to the Conference will not be allowed to participate.

If a registered delegate is not able to participate in the Conference, the already paid participation fee shall not be subject to reimbursement. The Participant shall have the right to replace a delegate.

Payment for a participation package or other services specified in the AGREEMENT shall be considered as conclusion of AGREEMENT for relevant services provision stated in the AGREEMENT. After the Conference, the Participant shall sign a Service Acceptance Certificate within five days after its receipt.

**PACKAGE “DELEGATE (without a report)”** includes: participation of 1 (one) delegate in all Conference events, section meetings, round-table sessions, information support, Conference hand-out package, coffee-breaks, lunches, invitation to the business reception, free access to the Exhibition.

**PACKAGE “DELEGATE (with a report-presentation)”** includes: 1 (one) report-presentation of products and services in a special presentation area, attendance at all section meetings during the conference, Conference hand-out package, coffee-breaks, lunch, visit of the exhibition, invitation to a business reception.

**INFORMATION FOR REPORT AUTHORS:** A registered delegate may make a presentation-report in a special area, if confirmed by the Organizer. The report duration and topic shall also be confirmed by the Forum Organizing Committee. The report topic shall correspond to the topics of the event. A Collection of Abstracts will be published by the beginning of the Conference based on the texts received from speakers. Abstracts shall be submitted in electronic form before **September 30, 2014** at [atomeks@atomexpo.com](mailto:atomeks@atomexpo.com). A copy of an official license for publication shall be provided along with abstracts. Abstracts will be published in Russian and English. All materials shall be made in Microsoft Word, font 12 Times New Roman, 1 space interval between the lines, up to 3 pages including tables, figures and references. Margins: left, top and bottom – 2 cm; right – 1.5 cm. Paper title, full name of the author and name of the company shall be indicated in the head section of the abstract. Illustrations (including formulas, tables, diagrams and charts) shall be numbered in accordance with references to them and have picture captions.

**PROCEDURE:** The Conference agenda will include a plenary session, topical section meetings, round-table sessions, presentation of supplier-companies. Sessions will be held in CEC Expocenter in conference halls. The working languages of the Conference will be Russian and English. Speakers shall have a possibility to use computers and projectors.

**LIABILITIES OF THE PARTIES:** In case of a failure to fulfill or in case of improper fulfillment of the AGREEMENT, Parties shall undertake to reimburse losses of another Party within the limits of the damage incurred in compliance with the legislation of the Russian Federation. The reimbursement of losses shall not relieve the Party from fulfillment of the undertaken obligations.

**FORCE-MAJEURE:** The Parties shall not be made liable for a failure to fulfill or improper fulfillment of their obligations under the Agreement resulted from force-majeure circumstances, i.e. emergency and unavoidable under given conditions including fire, terrorist act, natural disasters, war, military actions of any nature, decisions of state bodies. A Party that failed to fulfill or improperly fulfilled his/her obligations due to force majeure circumstances shall immediately inform another Party on occurrence and termination thereof. Documents (references) issued by relevant competent authorities shall serve as proper evidence of the above mentioned circumstances and their duration.

**PROCEDURE FOR DISPUTES SETTLEMENT:** Disputes and disagreement between the disagreement between the Exhibitor and the Organizer shall be settled through negotiations, and in case of failure to reach agreement, shall be settled by the Third-Party Arbitration Court for resolution of economic disputes at a private institution “The Center of Arbitration and Legal Appraisal” (CALA) (105064, Moscow, Yakovoapostolsky per., . 7, Building 2, Suite 300), in accordance with its regulations - <http://www.rosatom.ru/en/partnership/arbitrationcourt/>. The decision of the Arbitration Court shall be final. The applicable law is the law of the Russian Federation. The language of the dispute - Russian. In interpreting the text of the contract is taken into account its importance in Russian.

**OTHER CONDITIONS:** All requests for additional services shall be integral to the Agreement. As to other matters not covered by the Agreement, the Parties thereto shall be guided by ATOMEX 2014 Exhibitor's Handbook and applicable legislation of the Russian Federation. The contract is public. The organizer shall not favour one Party over another in relation to the conclusion of the Contract, except for cases stipulated by law and other legal acts.

The Agreement has been made on 2 pages signed by representatives of both Parties in 2 copies with the same legal force, one copy for each Party.
