The text of the signed Agreement received via fax or e-mail shall have legal force under condition and before mandatory exchange of originals (before or during the Exhibition). By the Agreement, the Exhibitor confirms his/her intent to participate in the Forum, guarantees full payment and undertakes to observe all terms and conditions of the Agreement and ATOMEX 2014 Exhibitor's Handbook.

For the purposes of the Agreement, the following terms are used:

**Exhibition:** International exhibition of nuclear industry suppliers ATOMEX 2014.

**Dates of the Exhibition:** October 29–31, 2014. Erection of booths on October 27–28, 2014; dismantlement – October 31, 2014 from 15:00 to 24:00 and November 1 from 0:00 to 8:00.

**Organizer** – Atomexpo, LLC.

**Exhibitor** – a person who signed the Agreement.

**The venue of the Exhibition:** Central exhibition center Expocenter, address: 14, Krasnopresnenskaya nab., Moscow, 123100, Russia, tel.: +7 (495) 795-37-99, 795-39-46, fax: +7 (495) 605-75-10.

**PAYMENT PROCEDURE:** Total cost of services related to the Exhibitor's participation in the Exhibition includes the following:

- payment for the booth area;
- registration fee;
- payment for remote participation;
- payment for additional services as per attached requests.

The Exhibitor shall pay against the issued invoices within ten banking days from the date of an invoice receipt by wire transfer to the Organizer's bank account.

The Exhibitor shall pay by wire transfer 100 % of the prepayment in Euro. **All bank charges and commissions are debited from the Payer's account.**

**If the Exhibitor makes payment after October 01, 2014, the Exhibitor's information shall not be published in the Exhibition Official Catalogue.**

Violation of payment terms by the Exhibitor shall entitle the Organizer to unilaterally repudiate the Agreement and to prohibit participation of the Exhibitor in the Exhibition.

Additional services ordered by the Exhibitor during the Exhibition shall be paid against issued invoices not later than 5 (five) banking days after the Exhibition closure. The Exhibitor shall have the right to require in writing that the Organizer eliminates the faults in the provided services within one working day from the date he/she receives an appropriate written request from the Exhibitor. In the absence of the Exhibitor's requests to eliminate the faults, the services shall be deemed to be properly rendered. After the Exhibition closure, the Exhibitor shall sign a Service Acceptance Certificate within five days after its receipt.

**LIABILITIES OF THE PARTIES:** Rights and responsibilities of the Exhibitor under the Agreement shall not be transferred to another person. The Exhibitor shall not have the right to place exhibits of third parties at his/her booth area without coordination with the Organizer. The Exhibitor shall use the booth area only for its intended purpose and in accordance with the booth layout. The Exhibitor shall distribute promotional products or carry out other advertising activities exclusively within the boundaries of his/her booth. The Exhibitor shall organize and carry out his/her activities at the booth so as not to hinder movement of visitors in the aisles and not to endanger or violate the rights of other exhibitors and visitors. The Exhibitor shall reimburse the Organizer for damage caused to the Organizer's property as well as expenses incurred by the Organizer to compensate for damage caused by the Exhibitor to the third parties' property. The Exhibitor shall observe safety precautions, fire safety rules, and industrial hygiene regulations effective at the territory of the CEC Expocenter. During the Exhibition, the Exhibitor shall have no right to carry out the activity that is prohibited or contradicts the applicable legislation of the Russian Federation. The Organizer shall not be made liable for loss or damage of exhibits and other tangible property owned by the Exhibitor incurred during booth erection/dismantling and during the Exhibition. The Organizer shall ensure general security of the exhibition hall from 18:30 till 9:00 of the next day; cleaning of the common Exhibition area and aisles of the exposition; general advertising of the Exhibition; and common lighting.

**The Exhibitor's refusal to participate in the Exhibition or follow the terms and conditions of the Agreement after its signing by the Exhibitor shall entail payment of a forfeit by the Exhibitor in favor of the Organizer to the amount of 100 % (one hundred percent) of the Exhibition participation cost, as set forth at page 1 of the Agreement.**

In exceptional cases, after signing the Agreement the Organizer shall reserve the right to change location and size of the area provided to the Exhibitor.

**CANCELLATION OR CHANGE OF DATES OF THE EXHIBITION:** In case the dates of the Exhibition are changed or the Exhibition is cancelled by the Organizer and the Exhibitor is notified thereof at least one month prior to its opening, the Organizer shall not be made liable to the Exhibitor for losses incurred by him/her due to the Exhibition cancellation. Thereof, the Organizer shall fully reimburse the Exhibitor, on the Exhibitor's request, for all cash amounts received from the Exhibitor.

**FORCE-MAJEURE:** The Parties shall not be made liable for a failure to fulfill or improper fulfillment of their obligations under the Agreement resulted from force-majeure circumstances, i.e. emergency and unavoidable under given conditions including fire, terrorist act, natural disasters, war, military actions of any nature, decisions of state bodies. A Party that failed to fulfill or improperly fulfilled his/her obligations due to force majeure circumstances shall immediately inform another Party on occurrence and termination thereof. Documents (references) issued by relevant competent authorities shall serve as proper evidence of the above mentioned circumstances and their duration.

**INSURANCE:** Exhibits, goods, personnel and other risks shall be insured by the Exhibitor.

**PROCEDURE FOR DISPUTES SETTLEMENT:** Disputes and disagreement between the disagreement between the Exhibitor and the Organizer shall be settled through negotiations, and in case of failure to reach agreement, shall be settled by the Third-Party Arbitration Court for resolution of economic disputes at a private institution "The Center of Arbitration and Legal Appraisal" (CALA) (105064, Moscow, Yakovoapostolsky per., . 7, Building 2, Suite 300), in accordance with its regulations - <http://www.rosatom.ru/en/partnership/arbitrationcourt/>. The decision of the Arbitration Court shall be final. The applicable law is the law of the Russian Federation. The language of the dispute - Russian. In interpreting the text of the contract is taken into account its importance in Russian.

**OTHER CONDITIONS:** All requests for additional services shall be integral to the Agreement. As to other matters not covered by the Agreement, the Parties thereto shall be guided by ATOMEX 2014 Exhibitor's Handbook and applicable legislation of the Russian Federation.

The Agreement has been made on 2 pages signed by representatives of both Parties in 2 copies with the same legal force, one copy for each Party.
