

According to the tradition, "Fair Supplier of Nuclear Industry 2013" diplomas were awarded. The main criteria for choosing the suppliers to be awarded with the diploma were the following:

- Fulfillment of treaty obligations: equipment delivery at the stated time, according to the stated cost;
- High quality of supplied products and provided services;
- Maintenance of factory warranty for equipment
- No annual rise in prices per equipment unit;
- Significance of works performed by the supplier for the industry;
- Absence of claims from customers for delivered products.


