For the purposes of these Terms and Conditions the following terms are used:

Conference: Conference in frames of the Forum of Nuclear Industry Suppliers «ATOMEX 2015»

Conference dates: October 13-15 2015

Since the number of delegates is limited, the Organizers do not guarantee acceptance of participation applications for the Conference if sent after 01 October 2015.

Since the number of reports in the Conference is limited, the Organizers have a right to decline applications of participation Delegate with a report-presentation if sent after 21 September 2015.

PAYMENT PROCEDURE: the Participant is to receive by fax and/or e-mail an invoice compiled basing on the filled in the AGREEMENT. The payment shall be made by wire transfer as a 100% advance payment in Euro.

The payment shall be made within 10 banking days commencing the invoice issue date. Speakers shall pay the registration fee not later than 21 September 2015. The delegates of the Participants who failed to pay the invoice before the Conference start will not be allowed to attend.

If a registered delegate is not able to participate in the Conference, the already paid participation fee shall not be subject to reimbursement. The Participant shall have the right to replace the delegate.

The payment of any kind of participation, specified by the AGREEMENT, will be considered as the acceptance of the provided services on the terms and conditions set forth in the AGREEMENT. After the Conference the Participant has to sign the Act on the services provided within five days of its receipt.

PACKAGE «DELEGATE (without a report)» includes: attendance of all Conference events, section sessions, round-table sessions, information support, Conference hand-out package, coffee-breaks, lunches, invitation to the evening reception, free access to the Exhibition for 1 delegate.

PACKAGE «DELEGATE (with a report)» includes: Package « Delegate (without a report), one report presentation at a special presentation area.

INFORMATION FOR AUTHORS: A registered delegate may make a presentation at one of the Conference events, if confirmed by the Organizer. The time and topic of the presentation shall also be confirmed by the Forum Organizing Committee. The presentation topic shall correspond to the topic of the event. By the beginning of the Conference a Collection of Abstracts will be compiled based on texts received from authors. Abstracts shall be submitted in electronic form not later than **21 September 2015** at atomeks@atomexpo.com. A copy of the official license for publication shall be provided along with abstracts. Abstracts will be published in Russian. Technical requirements: Microsoft Word format, font 12 Times New Roman, 1 space interval between the lines, 3 pages including tables, figures and references. Margins: left, top and bottom – 2 cm, right – 1.5 cm. Paper title, names of authors and organizations shall be indicated in the head section of the abstract. Illustrations (including formulas, tables, graphs and charts) shall be numbered respectively the references to them in the text and provided with captions.

PROCEDURE: The Conference agenda will include a plenary session, topical section sessions, round-table sessions, presentation of supplier-companies. Sessions will be held in the Congress Center of the World Trade Center in conference halls. The working language is Russian and English. Speakers are provided with computers and projectors.

RESPONSIBILITIES OF THE PARTIES: In case of a failure to fulfill or improper fulfillment of this AGREEMENT the Parties shall undertake to reimburse another Party the losses within the limits of the damage caused in compliance with the current legislation of the Russian Federation. The reimbursement of losses shall not relieve a Party from fulfillment of the undertaken obligations.

FORCE MAJEURE: The Parties shall not be made liable for a failure to fulfill or improper fulfillment of their obligations under this AGREEMENT resulted from circumstances beyond one's reasonable control, i.e. extraordinary and unavoidable circumstances under the given conditions, including a fire, terrorist act, natural disasters, war, military actions of any nature, decisions of the state bodies. A Party that failed to fulfill or improperly fulfilled its obligations due to circumstances beyond one's reasonable control shall immediately inform another Party on occurrence thereof. Documents (references) issued by relevant competent authorities shall serve as proper evidence of existence of the above circumstances and their duration.

SETTLEMENT OF DISPUTES: Any disputes occurred between Participant and Organizer shall be solved by the Parties by way of negotiations. If no appropriate solution is found, such disputes shall be solved by the Court of Arbitration for Resolution of Economic Disputes of the Center of Arbitral Regulation and Legal Examination, according to its bylaw. Decision of the Arbitral court shall be final. Applicable law is the law of the Russian Federation.

OTHER TERMS AND CONDITIONS: All extra services applications are essential parts of the Agreement. What is not stated by the Agreement should be ruled by “Atomex 2015 exhibition handbook” and by applicable law of the Russian Federation.

This AGREEMENT is made on two pages in two copies having equal legal effect, one copy for each of the Parties.

TERM OF VALIDITY: This AGREEMENT shall enter into force commencing the day of its signing by both Parties and shall remain in effect until **15 December 2015**.
