Liabilities of the Parties shall arise after the Exhibitor's payment of 100% of participation in the Exhibition.

Cost of additional services provided by the Organizer to the Exhibitor shall be determined as per the ATOMEX 2018 Exhibitor's Handbook and requests for additional services posted on

www.atomeks.ru/en and being inseparable parts of the Agreement.

The text of the Agreement and signed all applications and additions to it received via fax or e-mail shall have the same legal effect as the original. By this Agreement, the Exhibitor confirms its intent to take part in the Exhibition, guarantees full payment and commits to observe all terms and conditions of the Agreement and the ATOMEX 2018 Exhibitor's Handbook.

For the purposes of this Agreement the following terms are used:

Agreement: agreement for participation in the Exhibition of Nuclear Industry Suppliers ATOMEX 2018.

Exhibition: International Exhibition of Nuclear Industry Suppliers ATOMEX 2018.

Forum: X International Forum of Nuclear Industry Suppliers ATOMEX 2018, in which Exhibition and Conference are held.

Dates of Exhibition: December 3 - 4, 2018. Stands installation period: December 3 - 4, 1 - 2, 2018 from 9 a.m. until 8 p.m.; dismantling period – December 5, 2018 from 8 a.m. until 8 p.m.,

Organizer – LLC "ATOMEXPO"

PAYMENT PROCEDURE: Total cost of services to organize the Exhibitor's participation in the Exhibition includes:

- payment for stand area;
- · registration fee;
- payment for remote participation;
- payment for additional services as per attached requests.

The Exhibitor shall pay against provided invoiced within ten banking days commencing receipt by the invoice by wire transfer to the Organizer's bank account. The invoices are issued after the Organizer has received the sighed AGREEMENT.

The Exhibitor shall pay by wire transfer 100% of the prepayment in Euro.

All bank charges and commissions are debited for Exhibitor's account.

In case the Exhibitor makes the payment after November 12, 2018 the Exhibitor's information is not published in the Exhibition Official Catalogue.

A failure by the Exhibitor to pay in due time shall give the Organizer the right to unilaterally reject fulfilling of this Agreement and admitting the Exhibitor to participate in the Exhibition.

Additional services ordered by the Exhibitor during the Exhibition shall be paid against issued invoices not later than 5 (five) banking days after the Exhibition closure.

Exhibitors are entitled to request in writing from the Organizer disposing all the service limitations provided during one working day after receiving the written request from the Participant. If no written request is received in time allowed by the agreement, the services considered to be done properly. After the Forum the Participant has to sign the Act on the services provided within five days of its receipt.

RESPONSIBILITIES OF THE PARTIES: Rights and responsibilities of the Participant stipulated in this AGREEMENT shall not be subject to transfer to another person. The Participant shall not have the right to place exhibits of third parties within its stand area without coordination with the Organizer. The Participant shall use the stand area only for the intended purpose and in accordance with the Stand Plan. The Participant shall disseminate advertising materials or carry out other advertising activities exclusively within the boundaries of its stand area. The Participant shall organize the work of the exposition in the way that it will not restrain the flow of the visitors and will not create threat or right violation of the others. The Participant shall reimburse the Organizer for damage caused to the Organizer's property as well as expenses incurred by the Organizer to compensate for the damage caused by the Participant to third parties' property. The Participant shall respect safety precautions, fire safety rules, industrial hygiene regulations in effect on the Gostiny Dvor premises. The Participant shall not organize any activity during the Forum that is prohibited by the Russian Federation law. The Organizer shall not be made liable for loss or damage to exhibits or tangible property owned by the Participant incurred in the course of assembly, disassembly and work of the Exhibition. The Organizer shall ensure general security of the exhibition hall from 18.30 till 09.00 of the next day; general cleaning of the common territory and aisles of the exposition; general advertising of the Exhibition; common lighting.

In case of receipt of the Exhibitor's refusal to participate in the Exhibition until November 13, 2018 inclusive, the money received by the Organizer shall be returned to the Exhibitor after deducting administrative expenses in the amount of 25% of the Agreement amount.

In case of receipt of the Exhibitor's refusal to participate in the Exhibition after November 13, 2018, the money received by the Organizer is not returned to the Exhibitor.

Refusal to participate in the Exhibition must be executed by the Exhibitor in writing and provided to the Organizer by fax or e-mail.

In exceptional cases, after signing of the Agreement the Organizer shall reserve the right to change location and size of the space provided to the Exhibitor.

CANCELLATION OR CHANGE OF DATES OF THE FORUM: In case the dates of the Exhibition changed or it is cancelled or its procedure is changed by the Organizer and the Exhibitor has been notified thereof not later than one month before the Exhibition opening the Organizer shall not be made liable before the Exhibitor for losses the latter sustained due to the Exhibition cancellation. With that, the Organizer shall fully reimburse the Exhibitor, on the Exhibitor's request, for all cash amounts received from the Exhibitor.

FORCE MAJEURE: The Parties shall not be made liable for a failure to fulfill or improper fulfillment of their obligations under this AGREEMENT resulted from circumstances beyond one's reasonable control, i.e. extraordinary and unavoidable circumstances under the given conditions, including a fire, terrorist act, natural disasters, war, military actions of any nature, decisions of the state bodies. A Party that failed to fulfill or improper fulfilled its obligations due to circumstances beyond one's reasonable control shall immediately inform another Party on occurrence thereof. Documents (references) issued by relevant competent authorities shall serve as proper evidence of existence of above circumstances and their duration.

INSURANCE: Exhibits, goods, personnel and other risks shall be insured by the Exhibitor.

SETTLEMENT OF DISPUTES: Any dispute, disagreement or claim arising out of this Agreement and arising in connection with it, including those related to its violation, conclusion, modification, termination or invalidity, shall be settled by arbitration administered by the Russian Arbitration Center under the autonomous non-commercial organization "The Russian Institute of Contemporary Arbitration" in accordance with the provisions of the Arbitration Rules.

In the event that the above e-mail address is changed, the Party undertakes to immediately notify such change to the other Party, and in case the arbitration has already begun, also to the Russian Arbitration Center with the autonomous non-commercial organization "The Russian Institute of Contemporary Arbitration". Otherwise, the Party bears all the negative consequences of sending written statements, messages and other written documents to the non-actual email address. Parties undertake to voluntarily execute an arbitral decision.

The law applicable to this contract is the substantive law of the Russian Federation. The language of dispute resolution is Russian. The place of arbitration is: 123056, Moscow, 7 Gasheka str, 1, office N2140.

OTHER TERMS AND CONDITIONS: All requests for additional services shall be integral to this Agreement. As to other matters which are not subject to this Agreement, the parties thereto shall be guided by the ATOMEX 2018 Exhibitor's Handbook and applicable law of the Russian Federation.

This Agreement has been made on two pages signed by representatives of both Parties and being of equal legal effect.

The Exhibitor shall be considered familiarized with the ATOMEX 2018 Exhibitor's Handbook posted on the website www.atomeks.ru/en/

TERM OF VALIDITY: This Agreement shall enter into force commencing the day of its signing by both Parties and shall remain in effect until December 29, 2018.
